A native of Lancaster, Penny L. Wasem has lived in Lancaster her entire life, graduated from Lancaster City Schools and began college at Ohio University-Lancaster before moving to Athens her senior year. Penny majored in accounting and business pre-law and received a bachelor's degree summa cum laude from Ohio University, with a minor in Mathematics. She is licensed as a Certified Public Accountant and Certified Financial Planner. She recently earned the designation of Personal Financial Specialist (PFS). Ms. Wasem is registered with the Ohio Division of Securities as a Registered Investment Advisor.

Penny owns her accounting firm, with a focus on tax and fee-only financial planning. She has worked in the public accounting field for over 20 years. In addition, she worked part-time as the Financial Officer at the Fairfield County Foundation from 2003 through November, 2008.

On the community level, Penny currently serves on the Central Ohio Estate Planning Council and the Finance Committee for Fairfield Heritage Association. She is an active member of First Presbyterian Church, as well as being active in Sanderson PTO, Thomas Ewing PTO and Boy Scout Troop 106. She has previously served on several nonprofit boards in the community as President or Treasurer.

Penny joined the Lancaster Rotary Club in July, 1991, sponsored by our current District Governor, Tom Kokensparger. She served as Treasurer of our club for several years, and is currently the President-Elect.

On the professional level, Ms. Wasem is a member of the American Institute of Certified Public Accountants (AICPA), the Ohio Society of Certified Public Accountants (OSCPA), the AICPA Tax and Personal Financial Planning Divisions, the OSCP Tax and Personal Financial Planning Divisions, and the Financial Planning Association.

Penny is married to Eric Hubbard, and has two children, Clark, age 13, and Olivia, age 10. She spends most of her spare time attending the kids' activities, which include golf, volleyball, basketball, softball and band.

- Jan. 12 **Bruce A Harkey**, Executive Director, Franklin Park Conservatory Exhibit opening January 10: Orchid Forest, An Island Adventure. Orchids will transform the Conservatory's Pacific Island Water Garden with thousands of bright pink, yellow, orange, lime green, and purple blooms. "Each year we find a new way to highlight the orchid's beauty and mystique," said Bruce A. Harkey, Executive Director of Franklin Park Conservatory. "Visitors will be able to view the orchid up close along the rocks, water features, and tropical foliage." The exhibition will include several species including vanda, masdevallias, oncidium, dendrobium, cymbidium, and phalaenopsis.

- Jan. 19 **Georgianne Reuter**, Museum Director, Kelton House Museum (Underground Railroad stop in Columbus, Ohio)  
"The Kelton House is the only 'house museum' in the city of Columbus," said Georgianne Reuter, Kelton House Director. "It is the only place in the city where Columbus history can be seen and felt. We have the same furnishings, plates, silverware, clothing, and books that were used by the actual occupants of the house. This gives the Kelton House a realistic feeling that cannot be re-created, as most house museums are." Reuter says that the house museum concept is very effective in the education of children. Docents (tour guides), dressed in period costume, help make history come alive as they walk through the house and tell stories of the Underground Railroad, and life from 1850 to 1900.

- Jan. 26 **Joel Penton**, Former OSU Football player Joel Penton is a 2006 graduate of The Ohio State University and played 5 years of football for the Buckeyes. He was a member of 3 Big Ten championship teams and was a member of the 2002 National Championship team. Joel was also a 4-time Academic All-Big Ten selection. In his senior year, Joel received the prestigious Danny Wuerffel Trophy, also known as the "Humanitarian Heisman." The Trophy is a national award that recognizes the one college football player in the entire country who best combines exemplary community service with athletic and academic achievement. Joel is now an in-demand speaker who travels the country sharing his story with high school and middle school students.
