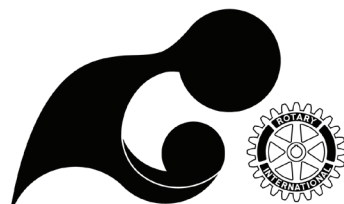

May 4 **Chastity Cooper**, *"Breast Cancer - What you need to know"*

Chastity M. Cooper, MPH, CHES, is the program Director of the Diversity Enhancement Program at the James Cancer Hospital and Solove Research Institute at the Ohio State Medical Center, Columbus, Ohio. The primary goal of this department is to increase the participation of minorities and underserved in clinical trials through education and institutional efforts. She previously served as the department's program manager for 4 years. Prior to working at The James, she spent more than 4 years with the American Cancer Society Franklin County Unit. Mrs. Cooper has made a number of presentations focusing on cancer education, prevention and treatment. Locally, Chastity is active in the American Cancer Society, the Columbus Chapter of the Oncology Nursing Society, the Ohio Society for Public Health Education and the Ohio Partners for Cancer Control. Mrs. Cooper received both her bachelor of science in education (1998) and her master of public health from The Ohio State University (2006). She is also a certified health education specialist since 1998.

May 11 **Anthony Knickerbocker**, *Career Technical Programs at LHS*

Mr. Knickerbocker has made outstanding progress in the Career Technical programs by instilling high expectations and accountability.
